



ADVICE FOR LEAVING A LEGACY TO CARE4CATS (In response to members enquiries)

If you wish to leave CARE4CATS a legacy we suggest that you take this form to your Solicitor when making your will. You will then be able to discuss exactly how much to leave and the most appropriate form of legacy to arrange. Leaving a legacy to CARE4CATS will help the Society to carry on with their valuable work with the stray and feral cats in Ibiza. Listed below are answers to some of the questions which are most frequently asked

What type of legacy would benefit CARE4CATS most?

* A residuary legacy would benefit CARE4CATS the most as it is not lessened by the rate of inflation. A residuary legacy is the remainder of your estate after other specific bequests have been made.

Can I leave a specific sum of money to the Charity?

* A specific sum can be left to CARE4CATS. It is the simplest form of legacy. It is worth remembering that this can be linked directly to the cost of living, which means that it does not reduce over time.

Am I able to leave specific items to CARE4CATS?

* Gifts such as property, jewellery and antiques would be most welcome.
(We would normally sell any property to raise funds).

If you do decide to leave us a legacy in your will, your solicitor could use one of the following phrases

If you wish to leave our Charity a sum of money:

I give to CARE4CATS, UK Registered Charity No. 1106345. Registered office: Brimar House, East Street, West Chiltington, West Sussex RH20 2JY, the sum of £..... and I direct a receipt signed by the Treasurer for the time being of the Society shall be a sufficient discharge for my executor.

If you wish to leave CARE4CATS a residuary legacy or a percentage of the residue of your estate

I give all the residue or% (a percentage) of the residue of my estate to Registered Charity No. 1106345. Registered office: Brimar House, East Street, West Chiltington, West Sussex, RH20 2JY and I direct a receipt signed by the Treasurer for the time being of the Society shall be a sufficient discharge for my executor

You may wish CARE4CATS to act as your Executor in which case one of the following clauses will have to be written into your will

* "I give a legacy of £..... to CARE4CATS whose Registered office is: Brimar House, East Street, West Chiltington, West Sussex RH20 2JY (UK Registered Charity No. 1106345) and I direct a receipt signed by the Treasurer for the time being of the Society shall be a sufficient discharge for my executor."

* "I appoint as the executors of this my Will the Secretary and Treasurer for the time being of CARE4CATS, whose Registered office is: Brimar House, East Street, West Chiltington, West Sussex, RH20 2JY (UK Registered Charity No. 1106345)".
